Terms & Conditions

- E-Auction of Vehicles shall be conducted on **as is where is basis** as per Disposal of Public Assets Regulations-2024.
- E-bidding Shall be available for the registered bidders on EPADS v2.0. Manual bids shall not be accepted. The bidders shall participate on-line in e-Auction through their **EPADS v2.0** accounts.
- Bidders shall upload their electronic bids through EPADS before the closing of the e-auction till **Thursday, August 27, 2026 11:00 AM**. Late bids shall not be accepted by the system.
- Interested bidders are advised to inspect the vehicles during office hours at Aiwan-e-Sadr, Sector G-5, Islamabad before submission of bids. The Participants must bring original CNIC and attested copy of CNIC. No claim regarding the condition of the vehicle(s) shall be entertained after the auction.
- The Earnest Money shall be **10%** of the reserve price of each vehicle (fixed amount specified against each vehicle). Bids submitted without the prescribed Earnest Money shall be **rejected**.
- The Bids shall be valid for the period of 120 days.
- Earnest money in the form of a Bank Draft/Pay Order, drawn in favour of the Deputy Director (General), President's Secretariat (Public), Aiwan-e-Sadr, Islamabad, shall be submitted separately against each vehicle for which a bid is being submitted.
- The original Bank Draft/Pay Order must be received in this office on or before 11:00 AM August 27, 2026.
- The Earnest Money of unsuccessful bidders shall be **refunded** after completion of the auction process. The Earnest Money of the successful bidder shall be adjusted towards the offered bid/price of the vehicle.
- The successful bidder must deposit the remaining amount of bid and taxes within 15 days of Auction. In case of default/withdrawal advance earnest money shall be forfeited.
- The successful bidders shall have to pay all admissible government taxes in addition to bid amount.
- Transfer of ownership documents would be the responsibility of the successful bidder.

- Documents and vehicle will be delivered after complete payment only.
- Possession of the vehicle will be given to the successful bidder, after transfer of vehicle in his/her name from the ETO concerned.
- The Auction committee reserves the right to accept or reject all or any of the bid according to Disposal of Public Assets Regulations-2024, Regulation No.28
