1. The Chief Engineer (O&M) Tarbela 4th Extension Hydel Power Station has reserved Funds for the procurement planned for FY 2026-27. The Chief Engineer (O&M) Tarbela 4th Extension Hydel Power Station intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the **"Procurement, Installation, Commissioning, Testing and Training of IT/OT Security Equipment"** in respect of DCS Section of Tarbela 4th Extension Hydel Power Station, **on D.D.P. basis**". The Chief Engineer (O&M) Tarbela 4th Extension Hydel Power Station Invites E-bids from eligible Bidders for procurement of goods described in the bidding documents on EPADS v2.0. Contract period will be 120 days.
2. Single Stage-One Envelope will be used by adopting Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.
3. All Bids must be accompanied by a Bid Security amounting described in Bid Security Section in Bidding Document in the form of Pay Order, Banker's Cheque, Call at Deposit, Bank Guarantee. Where Bid Security is not required by the Procuring Agency, Bidders are required to furnish Bid Security Declaration as specified in Bidding Document.
4. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/>.
5. The electronic bids must be submitted by using EPADS on or before **29.09.2026 at 1100 hrs.** E-bids will be opened using EPADS v2.0 on the same day at **1130 hrs.** Manual submission of Bids shall not be entertained. Those vendors who have not yet registered on the new version of EPADS v2.0, may register themselves on <https://vendors.epads.gov.pk/>. 6. Each bidder shall furnish a Bid Security amounting to **PKR 60,000/-** in the form of CDR, bank draft in favour of Chief Engineer (O&M) 4th Extension HPS Tarbela, WAPDA. Hard copy (in original) of Bid security must reach to this office prior on or before bid closing time / bid submission time. Insurance guarantees will not be acceptable.
