**HIRING OF SECURITY GUARDS THROUGH OUTSOURCE**  
**CONTRACT AT JINNAH INTERNATIONAL AIRPORT KARACHI**

Pakistan Airports Authority (PAA) invites bids from reputable firms / Companies or organizations specializing in the Hiring of Security Guards duly registered with the Income Tax and Sales Tax Departments and listed on the Active Taxpayer List of FBR, and registered with EOBI and SESSI in compliance with Public Procurement Rules, 2004. The details of requirements are specified in the RFP Document uploaded on EPADS. The initial contract period will be Two (02) years, extendable for another Six (06) months only (subject to the mutual consent of both parties and satisfactory performance by the Service Provider).

Bids shall be submitted electronically on EPADS by or before **16<sup>th</sup> February, 2026** (1500 Hours) as per conditions set out in Bidding documents available on PPRA E-PAD System <http://eprocure.gov.pk> (**free of Cost**). Bid will be opened on same day at **1530 Hours**. Bidders are required to get registered at E-PADS PPRA (Federal) to access the bidding document and other relevant information including electronic bid submission.

**The method for hiring of outsource contractor will be based on 'Quality and Cost Based Selection Method' under 'Single Stage Two Envelope bidding procedure' as mentioned in Rule-36 (b) of PPRA Rules, 2004.** Bids must be submitted electronically through PPRA E-PADS web portal <http://eprocure.gov.pk> before closing time & date and the original Bid Security of Rs. 8,000,000/-, in the form of Pay Order and as per the bank account details provided in the Bidding Documents, must be submitted to the **office of Officer Incharge (HR), Jinnah International Airport, Karachi, Pakistan Airports Authority**, before the bid opening date and time. However, a scanned copy of the Bid Security (pay order) must be attached along with technical proposal on EPADS.
