## ELIGIBILITY

2. This Invitation for Bids is open to all Bidders meeting the following criteria:-

- a. Pakistan Engineering Council Certificate renewed for the **year 2025-26** with Category having Specialization Code as mentioned against above must be provided.
- b. **The bidder shall be in the active tax payer list (ATL), and will provide** income Tax Returns for last three years.
- c. The contractors are required to submit their registration for sales tax with Punjab Revenue Authority.
- d. The bidder must have completed at least two contracts of same nature along-with its successful completion certificate as main contractor **within Ten years**.
- e. The bidder should have an **Average Annual Turnover half times of the amount** mentioned against this work during last three years certified from audited financial statement.

- f. Bidder shall demonstrate **Cash or Cash Equivalents equal to 10% of contract value** and current contract commitments. In this regard bidder shall provide the bank statements of last one (01) year.
- 3. Eligible Bidders may obtain further information, inspect and acquire the Bidding Documents from the Office of **Superintending Engineer (Civil) FESCO, Faisalabad up-to 09.02.2026**.
  - a. **Bid must be submitted through E-PADS on 10.02.2026 up-to 11:30 AM**
  - b. **Bids will be opened through E-PADS on 10.02.2026 at 12:00 Noon**
- 4. Tender documents can be obtained / downloaded from the E-PADS/PPRA Website ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) and the same may be uploaded on E-PAD after completing the required documents.
- 5. All bids must be accompanied by a Bid Security amounting to **5% on BOQ amount** each in favor of **Executive Engineer (Civil) Civil Works Division-II FESCO Faisalabad** of any scheduled bank of Pakistan and shall be valid 28 days beyond bid validity. The bid shall be valid for **140 Days**.
- 6. The bids will be opened at the office of **Superintending Engineer (Civil) FESCO, Faisalabad** in the presence of bidders / bidder's authorized representatives who choose to attend the opening process.
- 7. The bidder must stamp & sign at each page of bidding documents and all enclosures.
