The bidders shall upload scanned copy of Bid Security on EPADS. Original Bid Security must be submitted to the Manager (Material Management) HESCO, Room No. 237-WAPDA Offices Complex, Hussainabad, Hyderabad on or before above-mentioned closing dates & timings of e-bids submission, failing which the e-bid shall be rejected. The electronic bids will be opened on EPADS on the same day at aforementioned dates & timings.
