The bidding shall be conducted in line with the open competitive bidding procedure (Single Stage TWO Envelope) of the Public Procurement Rules-2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time), and is open to all potential bidders.
7. All bids must be accompanied by a Bid Security in an acceptable form in the amount of 2% (Refundable) in favor of ASF AIIAP Lahore.
8. The original bid through EPADS (as well as in hard copies properly filled in, and enclosed in sealed envelope(s) must be delivered to the address ASF AIIAP Lahore) at or before **25<sup>th</sup> February 2026 1000 hrs.**
