Item No. 2: “*2 entrances (adjacent 90°)*” shall be deleted and replaced with: “*Single Entrance (One Side Only)*”
 - Addition of Minimum Clear Door Opening Sizes**

The following minimum clear door opening widths are hereby incorporated under operating parameter clause in Annexures:

 - Annexure “A”: Min. 800 mm clear door opening width.
 - Annexure “B”: Min. 1100 mm clear door opening width.
