Original bid security must be attached with the Technical proposal (hard format sealed envelope) and the bid security copy (pay order /bank guarantee) must be attached through EPADS online submission as well as before submission date & time.

Bids must be submitted electronically as well as in hard format, in a sealed envelope duly filled and attached with requisite information in the specified format provided in the bidding document , to address as mentioned below on or before prescribed schedule otherwise the submission shall not be considered. The sealed bids shall be opened on the same day at given time.

All bids will be opened through EPADS in the presence of procurement committee and bidders who opt to participate on date/time mentioned as per schedule.

Time period for performance of contract: Till the satisfactory completion of contract and warranty period.

PAA reserves all rights to accept and reject any or all the Tenders for sufficient and cogent reasons which will be communicated to the bidders on request. The decision shall be final / conclusive and shall not be challenged.
