The Bidder shall submit the separate Bid for each lot accompanied by separate bid security for each lot in the shape of CDR/DD/PO of **Rs. 75,000/-** in the name of **General Manager (Punjab-South) NHA, Retention Money Account**. Bid security of 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> Highest Bidders shall be retained till finalization of auction process. Failure to furnish the bid security shall lead to disqualification/rejection of respective bid.

The highest bidder of each lot shall submit 25% of his highest offered bid price at the spot in the form of CDR/DD/PO in the name of **General Manager (Punjab-South) NHA, Retention Money Account**, failing which the bid shall be rejected and bid security of the respective bidder shall be forfeited.
