5. Electronic bids prepared in accordance with the instruction provided in tender documents must be submitted by using EPADS on or before **12th March, 2026 at 10:30am**.
6. The scanned copy of Bid Security should be uploaded via EPADS, while the original must be sent to the KTDMC Purchase Department at the address provided below. It is mandatory that the original Bid Security is received before the bid submission deadline. Non-receipt of original bid security before the bid submission deadline will lead to Rejection of Bid.
7. The Bids will be opened publically on the same day at 11:00am by using EPADS, thereafter in public and in the presence of bidders’ representatives who choose to attend in the opening at the address given below:
