2. The procurement shall be carried out under the Principal Method of Procurement i.e., Open Competitive Bidding. The **Least Cost Based Selection (LCBS)** technique shall be adopted for the subject procurement, in accordance with the Public Procurement Rules, 2004 and other regulations, regulatory guides, procurement guidelines, or instructions issued by the Authority from time to time.
3. All Proposals must be accompanied by a Bid Security as mentioned in the Bidding Documents (Re-fundable) in shape of **Pay Order, Banker's Cheque, Call Deposit Receipt CDR** in the name of the Inspector General, National Highways & Motorway Police Islamabad.
4. The Bidders shall submit **hardcopy of the Bid(s)/ Proposal(s)** alongwith **Original Bid Security** at Logistics Branch NHMP Central Police Office, Mauve Area, G-11/1, Islamabad before opening date
5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS v2.0)**.
6. Interested bidders are required to get themselves registered on EPADS v2.0 to participate in Bidding process.
7. In case opening date is declared as a Public Holiday by the Government, the next working day shall deemed to be the date for opening of tender at the same time and place.
8. The Bids will be received **only from those firms who are registered with PPRA for e procurement on EPADS** for Tendering through their Email addresses which were provided to PPRA at the time of their registration.
9. The NHMP reserves the right to reject any/all bids at any time prior to acceptance of a bid in accordance with PPRA's Rules.
10. The e-bids, prepared in accordance with the instructions in the e-Bidding Documents, must be submitted through EPADS v2.0 on or before **Mar 17, 2026 10:30 AM**. Bids will be opened publicly on the **same day at 11:30 AM** in the presence of Bidder(s)/ representatives at NHMP Central Police Office, Mauve Area, G-11/1, Islamabad.
