**OUTSOURCING OF SECURITY SERVICES FOR PRCL**

1. Reference is made to the subject tender published in the newspapers *The News* and *Dunya* dated 25<sup>th</sup> February 2026.
2. The following amendments are made in the bidding documents:
  - a) Technical Evaluation Criteria:
    - The minimum technical qualifying score shall be 95 marks instead of 90 marks.
    - Criteria No. 01 shall be read as: *"NOC from Ministry of Interior, Government of Pakistan."*
    - Criteria No. 02 shall be read as: *"Valid license from Home Department, Government of Sindh as Security Service Provider for calendar year 2026 or evidence of submission of renewal documents along with NOC for the year 2025."*
  - b) Scope of Work:
    - The quoted wages must not be less than the Government-notified minimum wages applicable on the date of bid opening. Non-compliance shall result in disqualification of the bidder.
    - The deployed personnel shall be entitled to annual medical insurance coverage with a minimum limit of Rs. 500,000 per person per year and annual Group Life Insurance (GLI) coverage of Rs. 500,000 per person. Additionally, EOBI (Employees' Old-Age Benefits Institution) contribution shall be calculated at 5% of the minimum wage and SESS (Sindh Employees' Social Security) contribution at 6% of the minimum wage, as notified by the Federal/Provincial Government from time to time.
3. All other contents of the bidding document will remain unchanged.
