| 1                             | Inspection         | Un-serviceable motorcycles can be inspected within three working days before the auction date within office hours with permission of Director (Admin), NTC HQs, Islamabad.  |
| 2                             | Bid                | Sealed bids along with PKR.7,800/- be deposited in advance as bid security of work on <b>March 16<sup>th</sup>, 2026</b> till 1000 hours through CDR or Pay Order. Sealed bids will be opened on same day at 1100 hours and top 03 x bidders will be allowed to participate in open auction bid. The highest bid will be considered as successful bidder. |
| 3                             | Payment            | Remaining amount will have to be paid through CDR or Pay Order within 05 x working days subject to award of work by NTC.  |
| 4                             | Delivery / Removal | Sold motorcycles will have to be lifted by the successful bidder at his own expenses within 05x working days after approval/award of work by NTC subject to full payment by the bidder.   |
| 5                             | Forfeiture         | If the highest bidder fails to deposit the full amount within 05x working days, advance payment/ security amount will be forfeited/ confiscated in favour of NTC without further notice besides cancellation of bid.  |
