TERMS AND CONDITIONS:-

- The bidding documents are available on PPRA E-Pad portal only. No Hard copy issued.
- Only firm / contractors registered with PPRA on E-PADS as vendors are eligible through online E-PADS Tendering. The bidders shall complete and authenticate their complete E-Bids (by uploading PDF file) and it must be submitted online on e-procurement system (EPADS) website i.e. <https://eprocure.gov.pk>.
- The prospective bidders are required to submit Bids Security / Earnest Money (CDR) amounting to as above mentioned against work in favour of Cantonment Board Officer, Cantonment Board Multan, CDR must be issued from any schedule bank against firm's account. Name of firm should be clearly mentioned on instrument (Call deposit / CDR). The Prospective bidders shall be submitted three (03 days) before opening of Bids & Pay order is not acceptable.
- The Prospective bidders shall upload scanned copy of undertaking on original judicial stamp paper worth Rs. 1200/- that their firms are not involved in any litigation.
- The bidders will be evaluated in accordance with laid down evaluation criteria as per PPRA rules and according to advertisement terms & conditions.
- The bidder will be opened publicly on 31-03-2026 at 12:00 PM in the presence of Bidders authorized Representatives who choose to attend the opening session to be held at the office of Cantonment Board Multan.
- In Case the total bid amount is less than 5% below the NIT amount, the bidder shall submit call deposit as performance security equal to the difference between NIT amount and total quoted amount less 5% of NIT amount. This call deposit shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Bids not carrying the performance security shall be rejected. The performance security of the successful bidder shall be released after completion of the project.
- Participants / firms must submit attested copies of relevant documents with original bids security / CDRs.
- Quoted rates shall be inclusive of all applicable govt. (Federal / Provincial taxes).
- The successful bidder shall be bound to execute an agreement with the procuring agency and all terms & conditions including tender notice shall be binding on him.
- Bidder / contractor blacklisted by any government / semi government dept or involved in litigation or found to be indulged in corrupt and fraudulent practices will be considered nonresponsive by the procuring agency.
- Notification of the GRC constituted in terms of Rule-48 of public procurement Rules, 2004 is provided on EPADS at www.eprocure.gov.pk and www.ppra.org.pk.
- In case of any gazette / occasional holidays the tenders will be opened on next working day.
- The firm providing unsubstantiated and/or incorrect information is liable to legal action and disqualification from the bidding.
