**TENDER NOTICE**

The National Library of Pakistan (NLP) invites bids from reputable experienced firms registered with PPRA on EPADS and with Income Tax/Sales Tax Departments listed on FBR's Active Tax Payer List (ATL) to provide General/Non-Core Services (cleaning, plumbing, gardening etc.) at Office of NLP located at G-5, Islamabad, and regional office **Karachi** through EPADS only, initially for a period of one year, further extendable up to **Two** years with mutual consent on satisfactory performance of contractor.

ii. The bidders/firms must be registered with Employees Old Age Benefits Institution (EOBI) for EOBI deductions/payments under EOBI act.

iii. The firms should quote their rates while ensuring compliance with Federal Government's minimum wage requirements. Any increase or decrease in rates imposed by the Government or ICT administration during the term of this agreement shall be accommodated by the NLP.

iv. Interested and eligible firms/bidders must submit their bids through PPRA's EPADS using **Single Stage Two Envelop** procedure under the PPRA Rules, 2004 as manual bids shall not be accepted.

v. The bids must be submitted/uploaded latest by **Monday, 6<sup>th</sup> April, 2026 at 11:00 AM**, which shall be opened through PPRA EPADS on the same day at **11:30 AM** in presence of representative of the bidders who may wish to be present.

vi. Financial Bid/Proposal must be accompanied by the Bid Security/Earnest Money i.e. Rs. **250,000/-** (Rupees Two Hundred Fifty Thousand only) and must be delivered in Original to the Office of the undersigned on or before **11:00 AM** of **6<sup>th</sup> April, 2026**.
