




The Rawalpindi Cantonment Board being procuring entity, invites sealed bids from eligible contractors/Firms on the basis of MES Schedule of Rates, 2021 (as amended upto date). Bids shall be quoted on percentage above/below or at par for schedule items, and on a market items rate basis for non-schedule items. The procurement shall be conducted under the “**Single Stage One Envelope Procedure**” in accordance with Rule 36(a) of the PPRA Rules 2004 (as amended upto date). Bids are invited from the contractors / firms having valid registration with Pakistan Engineering Council (PEC) in Relevant Category for the current financial year and whose names are appeared on the Active Taxpayers List (ATL) of the Federal Board of Revenue (FBR), for the following Work to be executed during Financial Year 2025-26: -

TERMS & CONDITIONS

- i. Bidding documents are available on PPRA at E-PADS portal only.
- ii. Only firms/contractors registered with PPRA on E-PADS as vendors are eligible through online E-PADS Tendering. The bidders shall complete and authenticate their complete E-bids and it must be submitted online on e-Procurement System (EPADS) website i.e. <https://eprocure.gov.pk>. in accordance with Rule 36(a) of Public Procurement Rules 2004 and terms & condition defined in the bidding documents.
- iii. The prospective bidders are required to submit Bid Security/Earnest Money (CDR) 2% of bid amount in favour of Cantt Executive Officer, Rawalpindi Cantonment Board, The Mall Rawalpindi Cantt, CDR must be issued from any schedule bank against firm's account. Name of Firm should be clearly mentioned on instrument (Call Deposit/CDR). The prospective bidders shall upload scanned copy of Bid Security on E-PADS and original will be submitted **Three (03) Days** before opening of Bids.
- iv. The prospective bidders shall provide Original Judicial Stamp Paper worth of Rs. 1200/- that their firm are not involved any litigations or blacklisting from any department.

- v. The prospective bidders are also required to submit their Bids online through E-PADS at <https://eprocure.gov.pk> before opening date. Original bids in accordance with the provisions of Rule 36 (a) of Public Procurement Rules 2004.
- vi. Bids must be submitted online on or before 07-04-2026 at 1330 hours. Bids shall be opened on the same day at 1400 hours in the presence of the contractors/firms or their authorized representatives who may wish to attend.
- vii. In case the total bid amount is up to five percent (5%) below the estimated cost, the bidder shall be required to submit a Call Deposit as Performance Security equal to five percent (5%) of the estimated amount. This Performance Security shall be in addition to the earnest money for the work and shall be deposited at the time of submission of bids. Any bid not accompanied by the requisite Performance Security shall be treated as non-responsive and rejected. The Performance Security of the successful bidder shall be released upon satisfactory completion of the project.
- viii. Quoted/Tender rates shall be inclusive of all applicable govt. (federal / provincial taxes).
- ix. The successful bidder shall be bound to execute an agreement with the procuring agency and all terms & conditions including tender notice shall be binding on him.
- x. Bidder/Contractor blacklisted by any government/semi government deptt or involved in litigation or found to be indulged in corrupt and fraudulent practices will be considered non-responsive by the procuring agency.
- xi. In case of any gazette /occasional holidays tenders will be opened on next working day.
- xii. The Firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding.
- xiii. Work order shall be issued subject to release of Grant-in-Aid.
- xiv. The Cantonment Executive Officer reserves the right to reject any or all bids at any stage prior to acceptance, in accordance with Rule 33(1) of the PPRA Rules, 2004.
- xv. Work-related information may be sought from the office of Engineering Branch Rawalpindi Cantonment Board, The Mall Rawalpindi Cantt.
