4. The electronic bids, must be submitted by using EPADS on or before 08/04/2026 at 11:00 A.M. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day at 11:30 A.M at 1st Floor, Estate Office Management, Islamabad.
5. The applicant firm shall obtain security clearance from the Additional Deputy Commissioner (Revenue), Murree to execute work at encroached area.
6. The Original bid security amounting to Rs. 200,000/- (Rupees two hundred thousand only) in the shape of CDR / Banker's Cheque issued in the favour of Drawing & Disbursing Officer, Estate Office Management, Islamabad and security clearance from the Additional Deputy Commissioner (Revenue), Murree must reach to the office the Assistant Director (Civil), Estate Office Management, 1st floor, Shaheed-e-Millat Secretariat, F-6/1, Islamabad in the office hours upto 07/04/2026, otherwise respective bid will not be opened.
