The Rawalpindi Cantonment Board (RCB), being the Procuring Agency, invites electronic bids (E-Bids) from reputable manufacturers / firms duly registered with FBR having valid NTN and Sales Tax Registration (STRN) and possessing relevant experience in manufacturing plastic or fiberglass municipal waste management products, to participate in the procurement of garbage collection poly carts for improvement of municipal sanitation services in Rawalpindi Cantonment.

**TERMS & CONDITIONS**

- i. Bidding documents shall be available only on PPRA and E-PADS portals. No hard copies shall be issued. Only firms registered on E-PADS as vendors shall be eligible to participate.
- ii. Bidders shall upload complete electronic bids (PDF format) on E-PADS (<https://eprocure.gov.pk>) in accordance with Rule 36(a) of PPRA Rules, 2004. Manual bids shall not be accepted.
- iii. The procurement shall be conducted under Single Stage – One Envelope Procedure as per PPRA Rules, 2004.
- iv. Bids shall be uploaded on E-PADS on or before 10-04-2026 at 11:30 AM.
- v. Bids shall be opened on the same day at 12:30 PM in the presence of bidders or their authorized representatives.
- vi. Bidders shall submit 2% of estimated cost in the shape of CDR issued by any scheduled bank, in favor of the Cantonment Executive Officer, Rawalpindi Cantonment Board.
- vii. A scanned copy shall be uploaded with the bid.
- viii. Original CDR shall be submitted within three (03) days prior to opening of bids.
- ix. The successful bidder shall execute a formal contract agreement with Rawalpindi Cantonment Board.
- x. The successful bidder shall supply and install the carts after issuance of work order.
- xi. The contractor shall provide minimum one (01) year warranty against manufacturing defects.
- xii. Firms blacklisted by any Government / Semi-Government organization shall not be eligible to participate.

- xiii. The contractor shall be responsible for all applicable taxes including Income Tax, Sales Tax and other statutory deductions.
- xiv. Technical details and inspection may be obtained from the Sanitation Branch, Rawalpindi Cantonment Board during office hours.
- xv. In case the opening date falls on a public holiday, the bids shall be opened on the next working day at the same time.
- xvi. Rawalpindi Cantonment Board reserves the right to accept or reject any or all bids in accordance with Rule 33(1) of PPRA Rules, 2004.
