- 3) To participate in the tender process, the bidders must register with FBR & have valid NTN certificate, active GST registration & professional tax certificate to ascertain the eligibility / Responsiveness. The bidders must submit the following mandatory documents:-
 - a) Attested copy of CNIC of the owner(s).
 - b) Copy of valid NTN & GST certificate and must be listed on the Active Taxpayer List (ATL).
 - c) Copy of Valid Professional Tax Certificate.
 - d) Affidavit of proprietorship, no blacklisting & litigation on E-stamp paper of minimum Rs. 500/-
- 4) Bid security must be submitted in the form of a Pay Order/Bank Draft from any scheduled bank, drawn in favor of "**Pakistan Airports Authority**". The Bidders must submit their bids & bid security and mandatory documents electronically through the PPRA EPADS Web Portal <https://eprocure.gov.pk> before the submission deadline.
- 5) The original bidding documents, original bid security in separate sealed envelope and mandatory documents must be submitted to the office of the Divisional Engineer ES Civil, PAA, MIAP, Multan before due date and time. The bidder(s) / Firm(s) not submitted the aforementioned documents shall be treated as Non-Responsive.
- 6) Responsive bids will be opened through **EPADS** in the presence of tender opening committee and bidders representatives who opt to participate, in the office of the undersigned on due date and time.
