1. The firm be registered with income tax and sales tax department (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
2. The firm should have proper Firm / setup at Karachi
3. The firm must have provision of preventive/ routine maintenance including all preventive checks.
4. The firm must have readily available spares to be made available on request whenever necessary.
5. A certificate shall be given by the bidder that he will be responsible for the free replacement of Floor and Building Plaster /store/Items/Spare parts if the same are found to be substandard at the time of Completion.
6. Each prequalified Firm performance in terms of quality, delivery, after sales, service, credit terms and other contractual obligations will be closely monitored and periodically reviewed during the contractual period.

13. The bidder is hereby informed that the Government shall deduct taxes at the rate prescribed under the tax laws of Pakistan, from all payments for services rendered by any vendor who signs a contract with the Government.
