Terms and Conditions:

1. The bidder must be registered with FBR/NTN to participate online in open auction through E-Pak Acquisition & Disposal System (www.epads.gov.pk/disposals), accompanied by Pay order as earnest money (refundable/ interest free), amounting to **Rs. 15,000/- (for all Motor Cycles), Rs. 20,000/- (each for Sr. No. ii & iii), and Rs. 17,950/- (for Sr. No. iv)** in favour of Pakistan Bait-ul-Mal, Islamabad on or before **28th April, 2026 till 11:00 hrs.**
2. Interested parties / individuals must submit original Pay Order and copy of CNIC on or before **28th April, 2026 till 11:00 hrs.** in PBM Head Office, Islamabad.
3. Interested parties / individuals can also submit their original Bank Draft/ CDR and copy of CNIC in their nearest PBM Provincial/ Regional Office (Admin/MT Branch) on or before one day of closing date.
4. Motorcycles and vehicles will be sold only when the highest bid exceeds the reserve price.
5. Successful parties / individuals must deposit 25% amount of the highest bid within three (3) days and balance amount (including taxes) of the highest bid within seven (07) days of the auction, otherwise earnest money and 25% of bid amount both will be forfeited in favour of Pakistan Bait-ul-Mal.
6. Motorcycles and vehicles will be delivered after full payment and after approval of the competent authority.
7. Successful bidder shall have to register Motorcycles and vehicles in his / her name within stipulated time frame after delivery.
8. Successful bidder shall have to pay all government taxes in addition to bid amount.
9. PBM Auction Committee reserves the right to accept or reject any or all the bids partially or fully, without assigning any reason according to PPRA rules.
