4. A complete set of E-bidding documents containing detailed instruction , eligibility criteria terms and conditions , Specification and requirements can be downloaded from E-PADS at (<https://epads.gov.pk>).
5. The electronic bids must be submitted by using **E-PADS 2.0 Version** on or before the scheduled date and time mentioned above against each tender.
6. The E-bids prepared in accordance with the Instructions contained in the bidding documents must be accompanied by Bid Securities of fixed amount and validity mentioned in bidding documents in favor of Deputy Manager Transformer Workshop QESCO Quetta in shape of a CDR/ Bank Guarantee from any scheduled bank of Pakistan.

One set hard copy of same bidding documents as uploaded / submitted **on E-PAD's 2.0 Version** along with supportive documents shall reach to the office of Deputy Manager Transformer Workshop QESCO Quetta on or before the scheduled date & time of E-bid submission mentioned against each tender / Lot.
