**TENDER NOTICE**

**PRE-QUALIFICATION OF VENDORS FOR REPAIR & MAINTENANCE SERVICES**

The Office of the Accountant General Pakistan Revenues (AGPR), Islamabad, invites electronic bids via EPADS from well-reputed firms/vendors for pre-qualification regarding the Repair & Maintenance of the following categories on an "As and When Required" basis for the Financial Year 2025-26 (extendable for a further period of one year upon mutual consent):

- **Category-I: Repair of Office Furniture & Fixture**
- **Category-II: Repair of Hardware & Equipment**

**TERMS & CONDITIONS:**

- 1. Eligibility:** Bids are invited from firms/workshops that are:
  - Registered with Income Tax and Sales Tax Departments.
  - Active on the Active Taxpayer List (ATL) of FBR.
  - Based in Islamabad/Rawalpindi with their own proper workshop/service center.
  - Not blacklisted by any Government/Semi-Government organization (an affidavit on stamp paper must be attached).
- 2. Bidding Procedure:**
  - Procurement shall be conducted through the EPADS system (<https://eprocare.gov.pk>) under the "Single Stage – One Envelope" procedure.
  - Vendors may apply for one or both categories. Evaluation will be carried out separately for each category.
- 3. Tender Documents:**
  - The Bidding Documents containing detailed specifications, evaluation criteria, and terms & conditions can be downloaded free of cost from the AGPR website ([www.agpr.gov.pk](http://www.agpr.gov.pk)) and the PPRA website ([www.ppra.org.pk](http://www.ppra.org.pk)).
- 4. Bid Security (Earnest Money):**
  - A Bid Security of **Rs. 100,000/- (Rupees One Hundred Thousand Only)** for each category applied for must be submitted in the shape of a Pay Order/Demand Draft in favor of "Branch Officer (Admn), AGPR, Islamabad".
  - The original financial instrument must be submitted to the undersigned physically before the bid closing time.
  - A scanned copy of the instrument must be uploaded with the technical proposal on EPADS.
- 5. Submission & Opening:**
  - Closing Date & Time: Electronic bids must be submitted through EPADS on or before **07<sup>th</sup> May, 2026, at 11:00 AM.**
  - Opening Date & Time: Bids will be opened on the same day at 11:30 AM via EPADS in the presence of bidders' representatives who choose to attend.

*Note: Manual bid submission (hard copies) is not allowed and will be rejected, except for the original Bid Security instrument.*
