
INVITATION TO BIDS

- 3- All e-bids must be accompanied by Bid Security amount mentioned in bidding document in the favour of Chief Executive Officer HESCO, in the shape of "Bank Guarantee" / CDR / Banker's Cheque from any scheduled Bank of Pakistan, valid for 28-days beyond bid validity date. The bidders shall upload scanned copy of Bid Security on EPADS. Original Bid Security must be submitted to the Manager (Material Management) HESCO, Room No. 237-WAPDA Offices Complex, Hussainabad, Hyderabad on or before above-mentioned closing dates & timings of e-bids submission, failing which the e-bid shall be rejected. The electronic bids will be opened on EPADS on the same day at aforementioned dates & timings.
