 - Technical and Financial Proposals should be submitted in separate envelopes, the words 'Technical Proposal' 'or' 'Financial Proposal' as the case may be, **No.9/13/2025-26/9-RPOs/Up-gradations/Log** being clearly written on the top of the respective envelope, bidders are required to mention quoted lot also and both 'Technical and Financial Proposal' should be in one envelope.
 - Initially Technical Proposal shall be opened by the Purchase committee on **7th May, 2026 at 12:00 PM** in the conference Room of this office. After technical evaluation, Financial Proposals of only technically qualified bidders shall be opened on a date/time to be announced subsequently.
 - All taxes shall be charged as per Government Rules on the subject.
 - Directorate General, Immigration & Passports reserves the right to cancel or reject any/all tenders under rule 33, of the Public Procurement Regulatory Authority (PPRA) Rules, 2004.
