**TENDER NOTICE**  
**SOLID WASTE MANAGEMENT**

Proposals / Bids are invited through from well-experienced Contractors/Firms having a minimum of Three (03) years' proven experience in the field of Municipal Solid Waste Management and duly registered with the Inland Revenue Department, for hiring of similar services within the jurisdiction of Walton Cantonment Board.

Interested contractors/firms shall submit their bids through **SINGLE STAGE - TWO ENVELOPE** procedure in accordance with Rule 36(b) of the PPRA Rules, 2004. The bids shall comprise separate **Technical Proposal** and **Financial Proposal**, to be uploaded in the respective designated envelopes/sections, clearly marked to avoid any ambiguity.

Bids shall remain valid for a period of one hundred eighty (180) working days from the date of opening of the bid

**A. SCOPE OF WORKS:**

The contractor shall be responsible for the following works.

1. Collection, transportation and safe disposal at location specified by WCB of municipal solid waste from different sectors of WCB area.
2. The services shall also include cleaning of roads, nullahs, open areas and removal of horticulture waste, dead animals and debris etc. in areas of operations.
3. Maintenance of rubbish points
4. Complaint resolution services
5. Provision of all equipment, machinery, fuel, labor, accessories and operational costs.
6. All services shall be provided strictly under performance-based model.
7. The contract period shall be three years extendable further on mutual consent.

**B. PERFORMANCE-BASED SERVICE MODEL:**

This is an output-based contract. WCB defines the cleanliness standards and KPIs. The contractor shall determine adequate fleet, manpower and operational deployment necessary to achieve the required standards.

No claim for additional payment due to underestimation of waste quantity, fleet requirement or manpower shall be entertained.

**D. EVALUATION CRITERION:**

1. Technical Evaluation – 60 Marks
2. Financial Evaluation – 40 Marks
3. Financial Score Formula:  $(\text{Lowest Evaluated Bid} \div \text{Bidder's Bid}) \times 40$
4. Most Advantageous Bidder shall be awarded the contract.
5. Technical bids shall be evaluated strictly on the basis of the disclosed evaluation criteria contained in this bidding document.

**E. SUBMISSION OF TENDER:**

1. Closing date for tenders to reach in the Office of Walton Cantonment Board, Ahmed Bukhsh Road Lahore is on 11-05-2026 at **01:30 pm hours**. Initially technical proposal shall be opened on same day at **02:00 pm hours** in presence of contractors or their authorized representatives who happened to be present at that time. The financial proposal of technically accepted bids shall be opened publically for which date & time will be communicated to the bidders in advance. The tender received late will not be entertained.
2. Conditional / posted/ telegraphically dispatched tender will not be accepted.
3. The outside of the envelope should be inscribed with Name of work and date of advertisement.
4. Tender documents can be obtained from the Office of Public Health Officer, Cantonment Board Walton Ahmed Bukhsh Road, Lahore during the office hours on payment of Rs.10,000/- (Non-Refundable) immediately after publication of this notice.

**F. GENERAL INSTRUCTIONS:**

1. **Tender shall be accompanied by bid security as specified against each Sector as mentioned above and in tender documents in the shape of Call Deposit Receipt (CDR) in the name of Executive Officer, Walton Cantonment Board, Lahore and will be attached with technical bid.**
2. The quoted rate in FINANCIAL PROPOSAL should be free from any cutting, erasing and overwriting etc.
3. No materials, tools, labor, or plants will be supplied by the WCB.
4. All those bidders who are black listed by any Government Department are not eligible for the bidding.
5. To clarify and discuss issues with respect to the CONTRACT and Bidding, WCB may hold pre-bid meetings(s).
6. The composite score under the Technical Proposal would be the arithmetic sum of the marks assigned to the bidders under each of parameters listed in the Bidding Documents.
7. The rate for each sector shall be quoted separately on prescribed format attached in bidding documents.
8. The attested copy of vehicle registrations owned must be provided for issuance of tender as per bidding documents.
9. All the vehicles to be provided by the Contractor should be of 2021 model or above.
