- b) No site visit will be allowed on the day of auction.
- c) No smoking, except in smoking area for public will be allowed inside and no match box/lighter will be carried inside the Airport.
- d) Airports security, admission, exit and other orders will be strictly observed by all during the period of auction.
- e) Airport Manager will have the right to reject any entry into the airport of any person without assigning reason.
- f) The controlling officer is authorized to withdraw from the sale any part of structure or quantity without assigning any reason.
- g) Bidders must submit bid security in the form of pay order/CDR/Demand draft (refundable) as mentioned in EPADS lot-wise in favor of Pakistan Airports Authority. Original Pay order/CDR/Demand draft (refundable) must be submitted in the office of Officer In charge Finance AIIAP before the date and time mentioned for closing of auction. Cash will not be entertained. Single pay order equivalent to total required bid security of all lots may be submitted in case the bidder is intended to participate in more than 1 lot.
- h) Pay order/CDR/Demand draft of unsuccessful bidders will be returned in original at the end of auction.
- i) The highest bidder will have to deposit full amount of the bid amount within 07 working days of issuance of award letter for auction.
- j) The successful bidder will have to deposit 5% performance guarantee in addition to auction amount which will be returned on successful lifting of auctioned items. PAA reserves the right to forfeit performance guarantee in case of failure to lift machinery in stipulated time or damage to PAA property.
- k) In case of failure to submit full amount within time frame, bid security of successful bidder will be forfeited.
- l) Income tax will be applicable as per govt. rules. The bidder shall be responsible for depositing of income tax as per applicable rate and providing CPR to PAA.
