

## **TENDER NOTICE**

**Pakistan Bait-ul-Mal (M/o PASS)** has reserved funds for the procurement plan for FY 2025-26. Pakistan Bait-ul-Mal (M/o PASS) intends to apply part of the proceeds of this fund to cover eligible payments under the contract for the procurement of summer/winter dresses and other items for 05 x PSHs under administrative control of PBM Regional Office ICT. Detail of items is given in the schedule of requirements of tender document.

2. **Pakistan Bait-ul-Mal (M/o PASS)** invites bids through **EPADS v2.0** from eligible bidders registered on **EPADS v2.0** for provision of the required items.

3. **Single stage two envelopes** procedure of principle method of procurement (i.e. Open Competitive Bidding) in line with the Public Procurement Rules, 2025 & any regulations, and instructions issued by the Authority (from time to time).

4. All bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Documents in the form of **Pay Order Call at Deposit** or Bid Securing Declaration on the prescribed format as described, amounting to Rs, **600,000/-**

5. E-Bidding documents, containing detailed term and conditions, specifications and requirements etc. or available on e-PAK ACQUISITION and disposal system (E-PADS at <https://vendors.epads/gov.pk/>).

6. The e-bids, prepared in accordance with the instruction in the e-Bidding documents must be submitted through E-PADS v2.0 on or before Tuesday 28<sup>th</sup> April, 2026 at 11:00 am. E-bids will be opened on the same day at 11:30 am at the address given below. Manual submission of bids shall not be entertained. Those vendors, who have not yet registered on the new version of E-PADS v2.0, may register themselves on <https://vendors.epads/gov.pk/>. In terms of rule 65 of Public Procurements Rules, 2025 Grievance Redressal Committee (GRC) is notified for the subject procurement and copy of the notification is available on the procuring agency's website ([www.pbm.gov.pk](http://www.pbm.gov.pk)) and also available on EPADS v2.0 as well as Authority's website at ([www.ppra.org.pk](http://www.ppra.org.pk)).

8. In case the date of opening is declared public holiday by the Government or non working day, due to any reason, the next official working day shall be deemed to be the date of submission and opening of tender accordingly. The time and venue shall remain the same.
