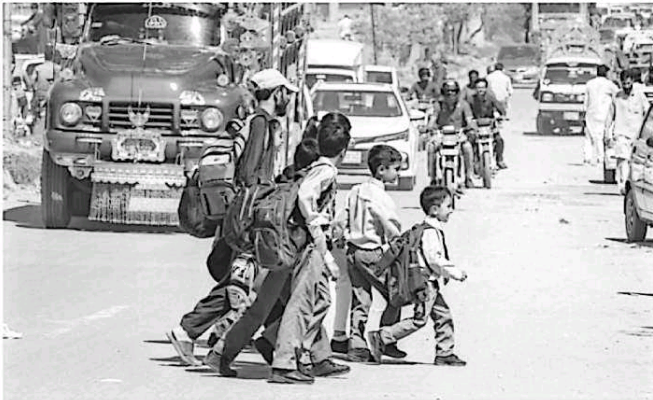

Young doctors press for reforms in meeting with Federal Health Minister

A delegation of the Young Doctors Association (YDA) from Khyber Pakhtunkhwa met Federal Health Minister Mustafa Kamal on Monday to discuss a range of professional and administrative challenges confronting early-career physicians.

During the meeting, the delegation outlined pressing concerns within the public health sector, with particular emphasis on the lack of a structured service framework, career progression issues, and other longstanding professional grievances affecting young doctors.

The minister assured the delegation that all legitimate and pending matters would be addressed on a priority basis. He reaffirmed the government's commitment to resolving the concerns of healthcare professionals, noting that their welfare is intrinsically linked to the delivery of effective and sustainable health services. Mr. Kamal stressed that practical and viable measures would be undertaken within available resources to ensure long-term solutions to the issues raised. He acknowledged the critical role of young doctors in strengthening the healthcare system and underscored the need for constructive engagement between stakeholders. The meeting concluded with both sides expressing the hope that continued dialogue would pave the way for meaningful reforms in the sector.

Meanwhile, Federal Health Minister Mustafa Kamal on Monday lauded the progress of the Sehat Kahani telemedicine initiative, calling for its expansion across the country to enhance access to affordable healthcare.

The minister expressed these views during a meeting with the Sehat Kahani team, led by its chief executive, Dr. Sara Saeed Khurram, where he was briefed on the programme's performance over the

past three months. According to the briefing, the digital healthcare model has been successfully implemented across eight Basic Health Units (BHUs) in Islamabad, as well as in several dispensaries in Karachi. The initiative has provided general and specialist consultations to thousands of patients, particularly in the fields of gynaecology, paediatrics and dermatology.

Data presented during the meeting indicated that 65 per cent of beneficiaries were women, with the highest patient turnout recorded among the 0-9 and 20-49 age groups. The figures suggest a marked improvement in healthcare access for underserved segments of the population. Officials further informed the minister that the programme addressed 15 major disease categories and significantly increased patient footfall in remote and previously underutilised health facilities. The initiative has also yielded an estimated cost saving of Rs8 million, attributed to reduced travel expenses, fewer private consultations and timely access to treatment. Several case studies were shared to illustrate its impact, including the early diagnosis of a congenital heart condition in a child, the identification of polycystic ovary syndrome in a woman facing prolonged infertility, and the swift containment of a scabies outbreak among children.
