
3. Inspection of Items:

4. Opening and Finalization of Bids:

- The Auction Committee reserves the right to accept or reject any bid amount without assigning any reason.
- The highest bidders will require depositing the whole amount of the bid at the spot. In case of failure, the bid will be treated as cancelled.

- Possession of all auctioned items must be taken instantly and removed from the site immediately.
 - Advance Tax @ of 5% is applicable.
5. **No Claim Policy:**
- No complaint or claim regarding the condition or completeness of items will be entertained after the bid is finalized.
 - Bidders are encouraged to fully inspect the lots before bidding.

- MOI&NC Islamabad reserves the right to accept or reject any or all bids wholly or partially without assigning any reason as per Rule 33 of the Public Procurement Rules, 2004.
