FMU, a Federal Government Organization, invites electronic bids (Technical & Financial Proposals) from Service Providers, who are registered with PPRA for E-Procurement on e-Pak Acquisition and Disposal System (EPADS v2.0), having Income, Sales Tax registration and Active Status on Active Taxpayer List (ATL) of relevant Tax Authorities. Bidding will be conducted pursuant to 'Single-Stage One Envelope procedure' under **Rule 36(a) of Public Procurement Rules (PPR), 2004**.

- To use the EPADS v2.0, unregistered bidders may first register on website <https://vendors.epads.gov.pk/login>. In case of any technical issues during registration or while using EPADS v2.0, prospective bidders may contact PPRA EPADS's technical support team via the EPADS v2.0 UAN: 051-111-137-237.
- The e-bidding documents, in accordance with relevant regulations and containing detailed terms, conditions, specifications, and requirements, are available to registered bidders on EPADS v2.0 at <https://epads.gov.pk/>.
- The bids shall be valid for 120 days. All electronic Bids must be accompanied by a Bid Security i.e., as specified in the table above, in the form of Demand Draft / Pay Order / Bank Guarantee made payable to "Financial Monitoring Unit, Government of Pakistan". The prospective bidders are required to upload scanned copy of Bid Security on EPADS v2.0.
- Original bid security must be submitted to the procuring agency on or before the closing time of bid submission failing which the bid shall be rejected.
- The electronic bids must be submitted through EPADS v2.0. Original Bid Security in a sealed envelope at the office address given below) on or before the deadlines specified in the table. Manual submissions of Bids will **not be accepted**. The electronic Bids will be publicly opened via EPADS v2.0 on the same day, as per schedule mentioned in the table, at FMU Office, 2nd Floor, Main Building State Bank of Pakistan, I.I. Chundrigar Road Karachi. In case the bid opening date falls on a public holiday, the bids will be opened on the next working day at the same time and venue.
