2. Registered Companies having NOC from the Ministry of Interior, Government of Pakistan, Home Department of all Provinces including Azad Jammu & Kashmir/Gilgit Baltistan are eligible to apply. The companies already blacklisted by the Government of Pakistan or terminated by NHA on account of poor performance or served with a notice on account of poor performance are not eligible to apply.

Bidding documents may be purchased on submission of a written application on the address given below upon payment of a Non-Refundable fee of Rs. 2,000/- (Rupees Two Thousand Only), Through Bank Draft or Pay Order in favor of **National Highway Authority, (NHA) Quetta**. The said Bidding Documents can also be downloaded from NHA website (www.nha.gov.pk) and draft of Rs. 2,000/- is to be attached with the Bids at the time of submission.

The Bids, completed in all respects duly sealed, signed and supported with documentary evidence should be submitted in a sealed envelope containing two separate envelopes both Technical & Financial Bids in the office of the Undersigned on **May 18, 2026 till 1130 Hours**. Only relevant documents are to be attached, brochures of the company of irrelevant material are not to be enclosed with bids. **Technical Bids** shall be opened on **May 18, 2026 (Monday) at 1200 Hours** in the presence of the representatives of the bidders who may choose to be present. However, Financial Bids of Only technically qualified bidders shall be opened later on.
5. Technical Bids should be submitted through Pay Order of Rs. 50,000/- in favor of National Highway Authority Quetta.
6. The Companies/Agencies providing unsubstantiated or incorrect information will be liable for legal action and disqualification, without any opportunity for clarification.
