1. Bidders are required to upload their bids on EPADS as per instructions of PPRA under procedure for single stage single envelope method till closing date/time.
2. Submitted bids shall be opened on same day at bid opening time at HRA&P Department, State Life Insurance Corporation of Pakistan, Central Zone, 4th Floor, 4-Ghazi IIm-ud-Din Shaheed Road, Lahore in the presence of bidders or their authorized agents, who wish to be present on the occasion.
3. In case if on bid opening day, holiday announced by The Government or Zonal Office could not operate due to any unavoidable reason, bid opening shall be held on very next working day at the same time.
4. **SINGLE STAGE, SINGLE ENVELOPE PROCEDURE** will be followed as per PPRA Rules 2004 for evaluation of bidders.
5. Estimated annual cost of this procurement is approximately Rs. 2,500,000/-.
6. Bid Security (Earnest money) including tax, of **Rs.100,000/-** in the shape of CDR/Pay order favoring “**State Life Insurance Corporation of Pakistan**” must be submitted in original by bidders on bid opening day before close of business hours. Bid without original CDR will be rejected.
7. The Bid Security will be returned to un-successful bidders after completion of formal procedure and to successful bidder completion of satisfactory performance.
8. Agreement period with successful bidder shall be 12 months, extendable for another 12 month with mutual consent on same costs, terms & conditions of this tender.
