Rawalpindi Cantonment Board (RCB), being the Procuring Agency, invites electronic bids from reputed, registered contractors/firms/companies, who are on the Active Taxpayers List (ATL) of the Federal Board of Revenue (FBR), for hiring of machinery/vehicles on rental basis (per day) including fuel (diesel/petrol) for a period of three (03) days on the occasion of Eid-ul-Azha 2026, in accordance with Rule 36(a) of the Public Procurement Rules, 2004 (as amended) under the Single Stage – One Envelope Procedure. TERMS AND CONDITIONS

1. Availability of Documents:

Bidding documents shall be available only on PPRA and EPADS V2.0 portals. No hard copies shall be issued. Only firms registered on EPADS as vendors shall be eligible to participate.

2. Submission & Opening of Bids:

E-bids, prepared in accordance with the instructions contained in the bidding documents, must be submitted electronically through EPADS V2.0 on or before:

Tuesday, May 12, 2026 at 11:00 AM

The bids will be opened on the same day at:

Tuesday, May 12, 2026 at 11:30 AM

3. Manual submission of bids shall not be entertained. Vendors not registered on EPADS V2.0 may register at: <https://vendors.epads.gov.pk/>

4. **Grievance Redressal:**

In accordance with **Rule 48 of PPRA Rules, 2004**, a **Grievance Redressal Committee (GRC)** has been constituted. The notification is available on the procuring agency's website and EPADS portal.

5. **Procurement Method:**

Procurement shall be carried out through **Open Competitive Bidding under Single Stage – One Envelope Procedure**, adopting the **Least Cost Based Selection (LCBS)** technique in line with PPRA Rules, 2004.

6. **Earnest Money:**

Bidders shall submit **2% of the estimated cost** in the shape of **Call Deposit Receipt (CDR)** issued by any scheduled bank in favour of the **Cantonment Executive Officer, Rawalpindi Cantonment Board**.

- i. A scanned copy shall be uploaded with the e-bid.
- ii. The original CDR must be submitted **at least three (03) days prior to opening of bids**.

7. **Award of Contract:**

Issuance of work order shall be subject to the approval of the **Competent Authority**.

8. **Eligibility:**


Firms/contractors **blacklisted by any Government/Semi-Government organization** shall not be eligible to participate.

9. **Additional Terms:**

Detailed terms and conditions may be seen in the office of the **Rawalpindi Cantonment Board** during working hours on any working day.

10. **Right of Rejection:**

The Procuring Agency reserves the right to **accept or reject any or all bids** prior to acceptance in accordance with **Rule 33(1) of PPRA Rules, 2004**, without assigning any reason.
