**HIRING OF PRIVATE SECURITY COMPANY FOR THE PROVISION OF SECURITY GUARDS TO NATIONAL HIGHWAY AUTHORITY, REGIONAL OFFICE GILGIT-BALTISTAN, AND ITS ATTACHED OFFICES**

It is hereby informed to all concerned that the subject Procurement process of the above-mentioned work/services is hereby **ANNULLED and re-advertised as under:-**

1. National Highway Authority (NHA) Regional Office Gilgit-Baltistan intends to invite bids from the interested Security Companies for the provision of **16x Ex-service Man armed Guards** at NHA Regional Office, Gilgit and its attached offices/locations, for a period of two years. **Single Stage-Two Envelope** procurement procedure will be adopted. Dealing companies having valid NTN/GST Registration and relevant experience are eligible to participate.
2. Registered Companies having NOC from the Ministry of Interior, Govt. of Pakistan, Home Department of all provinces, including Azad Jammu & Kashmir/Gilgit Baltistan are eligible to apply for pre-qualification. The companies black listed by the Government of Pakistan or terminated by NHA on account of poor performance or served with a notice on account of poor performance, are not eligible to apply.
3. Bidding documents may be purchased on submission of a written application on the address given below upon payment of a non-refundable fee of Rs. 5000/- (Rupees Five thousand only) in the form of a Bank Draft or Pay Order in favour of NHA Retention and Security Deposit Account Gilgit. The tender documents can be downloaded from NHA/PPRA website as given below and draft of Rs. 5000 is to be attached with the documents at the time of submission.

The Bids completed in all respects duly sealed, signed and supported with documentary evidence, should be submitted in a sealed envelope containing two separate envelopes for **Technical & Financial Proposals** in the office of the undersigned on or before **10<sup>th</sup> June, 2026 at 1100 Hrs.** Only relevant documents are to be attached. Brochures of the company or irrelevant material are not to be enclosed with the proposal. Technical Bids shall be opened on the same day at **1130 Hrs** in the presence of the representatives of the bidders who may choose to be present. However, Financial Bids of only qualified bidders shall be opened later on or before.
5. Financial Bid should accompany Pay order of Rs. 400,000/- in favour of NHA Retention and Security Deposit Account Gilgit.
6. The Companies/Agencies providing unsubstantiated and/or incorrect information will be liable for legal action and disqualification without any opportunity for clarification. NHA reserves the rights to reject any or all bids thereof as per PPRA Rules.
