Khyber Pakhtunkhwa, Workers Welfare Board, invites tenders (Single stage single envelope procedure) for the following work through EPADS from contractors enlisted with Workers Welfare Board (WWB), duly registered with Pakistan Engineering Council (PEC), and holding valid enlistment with WWB for the F.Y 2025-26, eligible contractors must also have deposited enlistment/renewal fee with WWB..

Terms & Conditions

- 1) The E-Bidding documents as per regulation containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders at K.P. WWB official Website: www.bkp.gov.pk & EPAD.
- 2) All electronic bids must be accompanied by a bid security, stamp duty and tender form fee in the form of either call deposit / demand draft / payment order as per amount mentioned against the work in favor of Secretary Khyber Pakhtunkhwa Workers Welfare Board, Peshawar. The prospective bidders shall upload a scan copy of the bid security etc. on EPADS. Original bid security etc. must be submitted to the procuring agency on or before the closing time on bid submission, failing which the bid shall be rejected.
- 3) Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bid.
- 4) Electronics bids must be submitted through EPADS on or before the bid closing date and time as specified above. Manual bid will not be accepted. Electronic bids will be opened by using EPADS publicly on the same day on 10.06.2026 in the committee room of KP WWB Main Office Building located at phase -V, Hayatabad, Peshawar.
- 5) Cutting and overwriting in the bid documents shall not be accepted.
- 6) The prospective bidders are also required to submit an undertaking on stamp paper duly attested by notary public worth not less than Rs.100/-, that the firm/ contractor are neither involved in any litigation nor blacklisted by any government or semi government or autonomous body in Pakistan and also under takes that if any information or documents provided by firm for issuance of tender documents is found in correct, the firm is liable for disqualification and legal action under the law.
- 7) The rate may be offered as %age above or %age below or At Par on estimated cost.
- 8) Contractors who submit bids more than 10% below and up to 20% below the estimated cost shall, along with their bids, provide an additional security equal to 8% of the estimated cost in addition to the 2% bid security. If the bid is not accompanied by the required additional security, it shall be treated as non-responsive, and the 2% bid security shall be forfeited in favor of the Government. In such a case, the second lowest bidder and subsequent bidders shall be considered accordingly.
- 9) Any bidder quoting a rate more than 20% below the Engineer's Estimated Cost shall, at the time of submission of the bid, furnish additional security equal to the difference between the bid amount and the Engineer's Estimate, along with a detailed rate analysis. Any bid falling beyond the threshold, if not accompanied by the requisite detailed rate analysis and/or the prescribed additional security, shall be declared non-responsive. The securities submitted with such non-responsive bids shall stand forfeited in favour of the Government, and the next lowest responsive bidder shall be considered accordingly. Furthermore, the additional security shall be released upon 100% completion of the project.
- 10) All the Government taxes (Federal, Provincial and any other) will be deducted as per the prevailing government policy.
- 11) The contractor or his representative may be present at a time of opening of electronic bid.
- 12) In case of tie/ draw amongst the responsive bidders the bid may be decided through free toss in the presence of Contractors which shall be considered as final.
- 13) The Khyber Pakhtunkhwa Workers Welfare Board reserves the right to accept or reject any or all bids, in accordance with the provision of Rule No.33(1).
