- v. The Tender shall be opened by a Procurement committee on **Monday, 1st June, 2026 at 12:00 PM**, in the Conference Room of this office. After technical evaluation, Financial Proposals of technically qualified bidders will be evaluated/announced subsequently.
- vi. A tender security in original amounting to **Rs.585,500/-** must be attached with the Proposal in the form of a Pay Order/Demand Draft/Bank Guarantee in favor of DGIP.
- vii. All taxes shall be charged as per Government Rules on the subject
- viii. The successful companies shall have to display their capability to deliver the equipment within the prescribed delivery schedule of **03 to 04 weeks** after signing of the contract.
