TENDER NOTICE

1. Estate office management, Islamabad attached department of Ministry of Housing & works invites sealed bids on Single Stage Single Envelope bidding procedure for the work “M.O. E/M Installations in Federal Lodges, Hostels and Family Suites at Islamabad. (SH: Skilled staff hired on monthly basis for EM Works)” from eligible Bidders registered on EPADS v2.0 having valid registration with income tax and Sales Tax Departments as Active Tax Payer.
2. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/> for all the interested bidders registered on EPADS v2.0. Bidders are required to get themselves registered on EPADS v2.0 to participate in Bidding process.
3. All the prospective bidders must upload the legible scanned copies of the documents of mandatory requirements given in the bidding documents, on the EPADS v2.0.
4. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **02/06/2026 upto 11:00 AM**. E-bids will be opened on the same day at **11:30 AM** at **Estate Office Management, Shaheed-e-Millat Secretariat, F-6/1, Islamabad**. Manual submission of Bids shall not be entertained. Those vendors who have not yet registered on the new version of **EPADS v2.0**, may register themselves on <https://vendors.epads.gov.pk/>.
5. The original bid security in the shape of CDR/Banker’s Cheque issued in the favour of Drawing & Disbursing Officer, Estate Office Management, Islamabad must reach to the office of the Assistant Director (E/M), Estate Office Management, Shaheed-e-Millat Secretariat, F-6/1, Islamabad anytime in the office hours before the online submission deadline of the bid, otherwise respective bid will not be opened.
