

**TERMS AND CONDITIONS PVMS MEDICINES AND DISPOSABLE ITEMS BULK LP  
MEDICINES , DISPOSABLE ITEMS AND LABORATORY ITEMS (FY 2026-27)**

1. Sealed quotations should reach to this office in hard copy and **USB** by 04 Jun 2026 before 1130 hrs. Tender will not be accepted after due date and time.
2. Tender will be opened on 04 Jun 2026 at 1200 hrs.
3. Tender should be provided as per format given by CMH Chunian. Tender will not be acceptable, if it is not according to given format.
4. Supplier shall be responsible for security clearance of his Firm / Coy as per rules and regulations laid down by GHQ. Security wise not cleared bidders will be declared unfit for tender.
5. Items declared unfit by AFMSL Lab will be replaced at cost of supplier.
6. All drugs/ vaccines /sera will be supplied according to the international standards of drugs storage.
7. Registered firms / companies will be bound to replace supplied items if remained unused 03 months before the expiry date.

**Validity**

1. The rates shall be valid from 01 Jul 2026 to 30 Jun 2027. The quotations must bear brand and generic names of the medicine separately **bearing the same PVMS / Disposable Items no as followed in list of medicines / specimen proforma provided, otherwise the quotations will not be accepted.**

**Discount on Bulk Local Purchase (BLP)**

2. The supplier / distributor shall offer maximum percentage of rebate on trade price

**Quality**

3. Medicines will not be accepted from pharmaceutical companies which are not registered with Ministry of Health, Pakistan.
4. The supplier will provide only genuine drugs as demanded and no substitute will be accepted. **No physician samples / fake medicines / expired / short life drugs shall be provided.**

**Bid Guarantee**

5. The Contractor will deposit **Rs.15,000.00/-** (Rupees fifteen thousand only) with Commanding Officer Combined Military Hospital Chunian Cantt in the form of **CDR / Bank Guarantee** as security which will be refundable (after 30 Jun 2027, any penalty / fine will however be deducted).

#### Packing

7. a. **All packs/ bottles / strips supplied must bear non erasable stamp stating "Not for Sale, 822219" any batch not duly stamped will not be accepted.**
- b. All medicines / surgical disposables should be out of fresh batch with long expiry date (not less than 02 years from date of supply).

#### Disqualifications

8. The tender opening committee has the right to reject / disqualify a company / supplier keeping in view its overall rapport among various CMHs, previous dealing with CMH Chunian and quality of medicine / disposable.

#### Undertaking

9. An undertaking shall be provided by the supplier that if the items/medicines are declared unfit by the laboratory or its efficacy found doubtful at any stage, the same will be replaced by the firm **without any financial implications on CMH Chunian.**

10. The supplier will be bound to replace the supplied medicines six months prior to expiry with new medicines / disposable items with 80% shelf life without any additional charges.
11. If a stock of medicines / disposable items is received by the hospital through CPMC / DGP Army then the hospital will not be bound to purchase such stock from the bidders / suppliers.
12. Rates will not be changed after submission of quotations to this hospital.
13. If a firm quoted the rate of an item to GHQ Medical Directorate / AM College and rate the said items is high from the rate quoted to this hospital, than supply orders will be initiated on the rate quoted to this hospital to prevent loss to the state.
14. Addition /deletion of items in list is prerogative of CMH Chunian, if supply order of an item (not enlisted in tender documents ) is issued than supplier is bound to supply items as per terms and conditions at rate fixed by GHQ Med Dte.

#### Delay in Supply of medicines

15. **Delivery time for national items is 30 days and 60 days for imported items** after receipt of confirmed supply order by the firm. In case of late delivery of items, the concerned firm / supplier will be liable for **fine @ 5% of total billing amount of that specific supply order**, after which bill will be processed. In case of repeated late supplies, CMH Chunian shall have the right to discontinue the contract with the concerned firm and **CDR for the said firm will be forfeited**.

#### Mode of payment to suppliers

16. Payment shall be made to suppliers through Controller Military Accounts, Lahore.

#### Income Tax

17. Income Tax will be deducted at the time of issuing of cheque from Controller Military Accounts, Lahore.
