3. The procurement shall be carried out under Single Stage - One Envelope Procedure in accordance with PPRA Rule 36(a) of Public Procurement Rules 2004.
4. All e-bids must be submitted through e-PADS. Manual submission of bids shall not be accepted / entertained.
5. Electronic bids must be submitted through e-PADS on or before **04 June 2025** at **11:00 Hours**. Electronic bids shall be opened on the same day at **11:30 Hours**. Technical and Financial evaluation shall be conducted on the same day.
6. In case the opening date is declared as Public Holiday by the Government of Pakistan, the next working day shall be considered as the date of submission and opening of bids at the same time and venue.
7. PLPA reserves the right to reject any or all bids under PPRA Rule-33 of Public Procurement Rules 2004 (amended to date).
8. Any bid received after the due date and time shall not be accepted.
