Bidders are required to get themselves registered on EPADS v2.0 to participate in Bidding process.
3. All the prospective bidders must upload the legible scanned copies of the documents of mandatory requirements given in the bidding documents, on the EPADs v2.0.
4. The electronic bids, must be submitted by using EPADS v2.0 on or before 08/06/2026 upto 11:00 A.M. Manual bids, shall not be accepted. Electronic Bids will be opened on the same day at 11:30 A.M at Estate Office, Shaheed-e-Millat Secretariat, F-6/1, Islamabad.
5. The Original bid security in the shape of CDR/Banker's Cheque/Pay Order issued in the favour of DDO, Estate Office Management, Islamabad must reach to the office of the Assistant Director (E/M), Estate Office Management, 1st floor, Shaheed-e-Millat Secretariat, F-6/1, Islamabad before the deadline for bid submission in the office hours, otherwise respective bid will not be opened.
6. The applicant firm should have performed three (03) E/M works having a minimum aggregate value of Rs. 4.000 million during last three years. Documentary evidence to this effect in the shape of work order and completion certificate duly attested by the concerned Project Director/ Engineer in charge must be uploaded on EPADS v2.0.
