


INVITATION TO BID - PROCUREMENT OF GOODS

1. The PMU HESCO (Hyderabad Electric Supply Company) has reserved Funds for the procurement planned for FY 2025-26. The PMU HESCO (Hyderabad Electric Supply Company) intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the "Tender No. PMU-207/25-26 for Procurement of Battery Bank & PMU-208/25-26 for procurement of Testing Sets".
 2. The PMU HESCO (Hyderabad Electric Supply Company) invites E-bids from eligible Bidders for procurement of goods described in the bidding documents on EPADS v2.0.
 3. **Single Stage-One Envelope** will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.
 4. All Bids must be accompanied by a Bid Security amounting described in Bid Security Section in Bidding Document in the form of **Pay Order, Banker's Cheque, Call at Deposit, Demand Draft, Bank Guarantee**. Where **Bid Security** is not required by the **Procuring Agency**, Bidders are required to furnish **Bid Security Declaration** as specified in Bidding Document.
 5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at <https://vendors.epads.gov.pk/>.
 6. Bidder are required to get themselves registered on **EPADS v2.0** on or before the bid submission date mentioned below E-bids will be opened using **EPADS v2.0** as per following detail:
