4. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **10/06/2026** upto **11:00 AM**. E-bids will be opened on the same day at **11:30 AM** at **Estate Office Management, Shaheed-e-Millat Secretariat, F-6/1, Islamabad**. Manual submission of Bids shall not be entertained.

The original bid security in the shape of CDR/Banker's Cheque issued in the favour of Drawing & Disbursing Officer, Estate Office Management, Islamabad must reach to the office of the Assistant Director (Civil), Estate Office Management, Shaheed-e-Millat Secretariat, F-6/1, Islamabad anytime in the office hours before the online submission deadline of the bid, otherwise respective bid will not be opened.
