- i. Documentary evidence for sales tax certificate, Bank statement and work experience / Supply orders completed in past 02 fiscal years should be attached with your request for scrutinization by committee and issuance of tender documents accordingly.
- ii. Tender documents shall be issued from 0900 to 1600 hours on Monday to Friday, after appearing in News papers.
- iii. Tender received after date of opening shall not be entertained. The minimum validity of the tenders rates must be **90 days** from the date of opening, otherwise tender will not be accepted.
- iv. In case of date of opening or submission is declared as a public holiday by the Government or non working day due to any reason, the next official working day shall be deemed to be the date of submission and opening of tenders accordingly.
- v. Issuance of tender documents shall be closed one day before the bid opening date. Furthermore, submission of tender will close one hour prior to bid opening time.
- vi. Tender must be accompanied with earnest money amounting to the 02 % of tendered cost in the form of Deposit-at-call titled as "**Earnest Money/Security Deposit Account**" drawn from any scheduled bank, failing which the tender will not be entertained.
- vii. Conditional bids will not be accepted.
- viii. Item rates shall be written in figure and in words. In case of difference the rate quoted in **words shall prevail**.
- ix. Incomplete proposal/bid shall not be entertained and treated as non-responsive.
