

PROCUREMENT OF CIVIL WORKS

1. The Director General Audit, Postal & Telecommunication Services, Islamabad has reserved Funds for the procurement planned for FY 2025-26. The Director General Audit, Postal & Telecommunication Services, Islamabad intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the "Provision of Internal Office (Aluminum-Glass) Partitioning and Civil Repair Works in Existing Office Building".
2. The Director General Audit, Postal & Telecommunication Services, Islamabad invites sealed Bids from eligible Bidders on Pak PWD Schedule of Rates 2022 for procurement of Works (Provision of Internal Office (Aluminum Glass) Partitioning and Civil Repair Works in Existing Office Building) described in the bidding documents on EPADS v2.0.
3. Single Stage-Two Envelope will be used by adopting Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.
4. All Bids must be accompanied by a Bid Security of Rs 320,000 (Pak Rupees Three Hundred Twenty Thousand only) in the form of CDR/Bank Draft in the name of Director General Audit, Postal & Telecommunication Services, Islamabad.
5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on e-Pak Acquisition and Disposal System (EPADS) at <https://vendors.epads.gov.pk/> for all the interested bidders registered on EPADS v2.0. Bidders are required to get themselves registered on EPADS v2.0 to participate in Bidding process.
6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before 2nd June, 2026 at 10:30 am. E-bids will be opened by using EPADS v2.0 on the same day at 11:30 a.m in the office of the Director General Audit Postal & Telecommunication Services, IBC building, Mauve Area, Sector G-10/4, Islamabad. Manual submission of Bids shall not be entertained. Those vendor who have not yet registered on the new version of EPADS v2.0, may register themselves on <https://pa.epads.gov.pk/>.
