E-bids will be opened on the same day at **03:00 PM** at **Estate Office Management, Shaheed-e-Millat Secretariat, F-6/1, Islamabad**. Manual submission of Bids shall not be entertained.

The original bid security in the shape of CDR/Banker's Cheque issued in the favour of Drawing & Disbursing Officer, Estate Office Management, Islamabad must reach to the office of the Assistant Director (Civil), Estate Office Management, Shaheed-e-Millat Secretariat, F-6/1, Islamabad or at the office of the Deputy Director, Estate Office Management, Lahore anytime in the office hours before the online submission deadline of the bid, otherwise respective bid will not be opened.
