



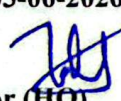
TENDOR NOTICE 05/2026

The office of Directorate of Intelligence, Lahore invites bids from Manufacturer/ Supplier duly registered with FBR (NTN/ GST) for Purchase of Uniforms and protective Cloths for the Officers and Staff through EPADs. Detail as under:

CONDITIONS

1. Firms meeting the criteria outlined in the bidding documents available on EPADS V2.0 (<https://eprocure.gov.pk>) may apply. The last date for submission of applications is as specified above. No bids will be accepted after the closing time. Manual submissions without uploading on EPADS are strictly prohibited.
2. Interested firms must submit a duly stamped and signed technical envelope, clearly mentioning the firm's name, address, and authorized representative's signature. The envelope must include:
 - Valid NTN certificate
 - Valid GST certificate
3. Bid security must be submitted in the form of a Call Deposit Receipt (CDR) in the name of the firm, in favor of the Deputy Director, Directorate of Intelligence, Lahore, issued by a scheduled bank of Pakistan. The CDR must be included in the technical envelope. Bids without bid security will be rejected at the technical evaluation stage. Cash or cheque will not be accepted.
4. Contractors must submit all required documentary evidence as specified in the bidding documents. Failure to comply will result in rejection of the tender.
5. All submitted documents will be verified from the issuing authorities. Any firm found submitting fake, false, or forged documents will face strict action under PPRA rules and may be blacklisted by FBR.
6. The procuring agency reserves the right to reject any or all bids or proposals at any time prior to acceptance. Upon request, the agency may communicate the reasons for rejection to bidders; however, it is not obligated to justify such decisions.
7. The bidding process will be conducted in accordance with the Public Procurement Rules, 2004, E-Pak Procurement Regulations, 2023, and any applicable regulatory guidelines or instructions issued by the Authority from time to time. The process is open to all bidders registered with EPADS.
8. The procurement will follow a **Single Stage – One Envelope Procedure** as per Rule 36(a) of PPRA.
9. Bids will be evaluated based on cost, quality, qualifications, or a combination thereof, as specified in the bidding documents, in accordance with PPRA Rules.
10. Electronic bids must be submitted through EPADS by **03-06-2026 at 12:00 PM**. Bids will be opened electronically on the same date at **2:30 PM** via EPADS.
