## **Procurement of Non-Consultancy Services**

4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of Pay Order, Banker's Cheque, Call at Deposit, Bank Guarantee, Demand Draft or Bid Securing Declaration on the prescribed format described.

6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through EPADS v2.0 on or before **Wednesday, May 20, 2026 11:30 AM**. E-bids will be opened on the same day at **Wednesday, May 20, 2026 12:00 PM**. Manual submission of Bids shall not be entertained.
