# INVITATION TO BID

## FOR PROCUREMENT OF GOODS/STATIONERY/MISC & ELECTRIC ITEMS

1. The **Military Accountant General Office, Rawalpindi (Pakistan Military Account Department (PMAD))** has reserved Funds for the procurement planned for FY-2026-27 The **Military Accountant General Office, Rawalpindi (Pakistan Military Account Department (PMAD))** intends to apply part of the proceeds of this funds to cover eligible payments under the contract for the "**Procurement of General/ Stationery, Other /Misc, Electric and Hardware Items for the FY-2026-27**".
2. The **Military Accountant General Office, Rawalpindi (Pakistan Military Account Department (PMAD))** invites E.bids from eligible Bidders for procurement of goods described in the bidding documents on **EPADS v2.0**.
3. **Single Stage-One Envelopes** will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, In line with the public procurement Rules, 2004 and any Regulations, Regulatory Guides, procurement Guidelines or instruction issued by the Authority from time to time.
4. All Bids must be accompanied by a Bid Security amounting described in Bid Security Section in Bidding Document in the form of **Pay Order, Call at Deposit, Demand Draft**. Where **Bid Security** is not required by the **Procuring Agency**. Bidders are required to furnish **Bid Security Declaration** as specified in Bidding Document.
5. E. Bidding Documents, containing detailed Term & Conditions, specifications and requirements etc, are available on **e.Pak Acquisition and Disposal System (EPADS)** at <https:vendors.epads.gov.pk/>.
6. Bidders are required to get registered themselves on **EPADS v2.0** on or before **Wednesday, June 10, 2026 at 11.00 AM**. E.bids will be opened using **EPADS v2.0** on the same day at **Wednesday, June 10, 2026 at 11.30 AM**. Manual submission of Bids shall not be entertained. Those vendors who have not yet registered on the new version of **EPADS v2.0**, may register themselves on <http://vendors.epads.gov.pk/>. 7. In terms of Rules-48 of Procurement Rules, 2004 Grievance Redressal Committee (GRC) is notified for the subject procurements and notification copy is available on the procuring agency's website at ([www.pppra.org.pk](http://www.pppra.org.pk)).
8. The Bidder will submit **Earnest Money/Bid Security as mentioned against each items in bid Security Section but not less then Rs.100,000/- (in any case)**, in the shape of Call Deposit/CDR/Pay Order in favor of "DDO MAG" Kashmir Road, Rawalpindi Cantt. Any bid not accompanied by Earnest Money shall be rejected without any right of appeal. In case of cancellation of purchase order due to default by the supplier the earnest money shall be forfeited.
