- The auction shall be carried out through EPADS v2.0, in accordance with PPPA Rules, 2004 (as amended) and the Disposal of Public Assets Regulations, 2024.
- In case of non-availability of registration documents, bidders shall have no right to claim any compensation or relief against PESCO.
- All bidders must be registered with the Federal Board of Revenue (FBR) for Income Tax and Sales Tax and must appear on the Active Taxpayer List (ATL).
- Bid Security / Earnest Money equal to the specified amount against each tender shall be:
  - Uploaded electronically on EPADS v2.0, and
  - Submitted in original (Pay Order / Bank Draft) in favor of PESCO Sale Proceeds Account at the office of Manager (Disposal), Room No. 306, PESCO Headquarters, Peshawar, before the closing date and time. Bids without valid bid security shall be rejected as non-responsive.
- Detailed bidding documents, including terms & conditions, evaluation criteria, and disposal procedures, are available on EPADS v2.0 for registered bidders.
- Manual / physical bids shall not be accepted. All bids must be submitted electronically through EPADS within the stipulated date and time.
- Bids shall be opened electronically on EPADS at the specified date and time in the presence of bidders/representatives who may choose to attend.
- The highest evaluated responsive bid shall be accepted, subject to approval by the competent authority as per PPPA Rules.
- PESCO reserves the right to accept or reject any or all bids at any time prior to acceptance, in accordance with Rule 33 of PPPA Rules, without assigning any reason.
- In case of any grievance, bidders may approach the Grievance Redressal Committee (GRC) constituted under relevant provisions of PPPA. Details are available on EPADS.
